- Tourism

MIGRANT (M)

- Training
- Religious
- Work
- Spouse
- Pension

RESIDENT (R)

- Family of colombian national
- Qualified
- Investment



TYPES OF VISAS

MIGRANT VISA

PENSION / RENTISTA / INVESTOR

TERM: 1 TO 3 YEARS / MULTIPLE ENTRANCES

- Monthly pension of **US \$900**
- Monthly yield of **US \$2.800**
- Investment in colombian company for **US \$27.000**
- Investment in colombian real estate for **US \$90.000**



TYPES OF VISAS

PERMANENT VISA

CATEGORIES OF PERMANENT VISAS

TERM: 5 YEARS TO INDEFINITE / MULTIPLE ENTRANCES

- Investors
- Holder of migrant visa
- Family related



TYPES OF VISAS

PERMANENT VISA

INVESTORS

TERM: 5 YEARS TO INDEFINITE / MULTIPLE ENTRANCES

- Foreign investment in Colombia of US **\$160.000**
- No threshold distinction between real estate and companies



TYPES OF VISAS

PERMANENT VISA

VISA FOR MIGRANT VISAS HOLDERS

TERM: 5 YEARS TO INDEFINITE / MULTIPLE ENTRANCES

- Hold migrant visa for **5** continuous and uninterrupted years
- Hold spouse visa for **2** continuous and uninterrupted years



TYPES OF VISAS

	MIGRANT	PERMANENT
TERM	From 1 to 3 years, multiple entrances	5 years to indefinite, multiple entrances
CRITERIA	Real estate investment of 350 CMW US \$90.000 Capital contribution to a colombian company for CMW US \$27.000	Foreign investment in Colombia for at least 650 CMW US \$160.000 No threshold distinction between real estate and companies
MINIMUM STAY	1 visit every 180 days	1 visit every 2 years



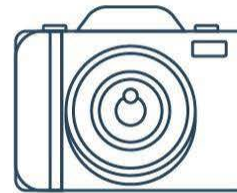

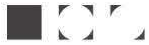

TYPES OF VISAS

CITIZENSHIP

Hold a permanent visa and complete 5 years
of continuous **domicile** in Colombia



DOMICILE?

TYPES OF VISAS

- A foreigner is considered to be domiciled in Colombia **from the moment a Permanent Visa is granted**
- Domicile is interrupted if foreigner remains outside of Colombia for more than **1 continuous year**



TYPES OF VISAS

BENEFICIARIES

Visa holders may request beneficiary visas for the following individuals, as long as they economically depend on visa holder

- Children under **25**
- Spouse
- Parents
